Leadership Through Sportsmanship 2017 Application

Tuition for the Leadership Through Sportsmanship program is \$4,850 (if paying by check) or \$5,000 (if paying by credit/debit card). A non-refundable deposit of \$350 is required at the time of enrollment. The tuition includes program costs, accommodations and most meals, sightseeing, and YFI T-Shirt. It does NOT include round-trip travel to London and spending money. No refunds for the cost of tuition will be honored; however, recommended trip cancellation insurance will cover cancellation due to emergencies and serious illness, accident, or injury.

Each program session is limited to 30 boys and 30 girls and enrollment is filled strictly on a first-come, first-served basis. If the program is full, payments will not be processed and will be returned.

A. Registration Process and Payment Methods

Payments may be made via check or credit/debit card as indicated on the Leadership Through Sportsmanship application. Deposits are non-refundable.

Should any payment return due to insufficient funds or credit card denial, registration will be denied unless addressed and successful repayment is made within 72 hours of notice. Should registration be denied due to insufficient funds/credit card denial, all previous payments made are non-refundable.

Program registrations will not be confirmed until the completed form and the correct payment are received in full and processed by Youth Futures International.

B. Cancellation Policy

Program registration fees are non-refundable if participation is cancelled.

C. Expenses

Participants in YFI's Leadership Through Sportsmanship program will be participating voluntarily without financial compensation and assuming all expenses outside the expenses inclusive with tuition. YFI will not be responsible for personal expenses such as meals outside prearranged program meals, souvenirs, or fees related to non-agreed-upon program expenses.

YFI is not responsible for the loss/theft/damage of personal money or property.
